### Presidents Corner:

#### **STREET PARKING**

I WANT TO ONCE AGAIN CLARIFY THE HOA'S POSITION ON PARKING ON THE STREET. OFFICIALLY, WE DISCOURAGE IT, BOTH FOR AESTHETIC AND SAFETY REASONS. HOWEVER, OUR HOA CANNOT MANDATE SUCH A REQUEST. CONTRARY TO SOME RESIDENTS OPINION, THE WALDEN COVENENANTS DO NOT ADDRESS PARKING ON PUBLIC ROADWAYS; ONLY PARKING "WITHIN A LOT".

IN FACT, VEHICLE PARKING ON A RESIDENTIAL SUBDIVISION STREET IS SPECIFICALLY ALLOWED UNDER CITY ORDINANCE, AND OUR COVENANTS CAN NOT AND DO NOT TRUMP A CITY LAW. HOWEVER, THOSE VEHICLES MUST BE OPERABLE AND HAVE A CURRENT LICENSE PLATE. BOATS, TRAILERS, MOTOR HOMES, RV'S AND MOBILE HOMES ARE PROHIBITED FROM BEING PARKED ON A RESIDENTIAL STREET. TRUCKS, TRACTOR TRAILER OR BUSSES PARKED IN A RESIDENTIAL SUBDIVISION MUST BE IN USE (BEING LOADED OR UNLOADED). PARKING IN FRONT YARDS OR ON GRASS IS ALSO NOT ALLOWED UNDER CITY OPRDINANCE.

## **Treasurers Report**

2015 was a year focused on repair and maintenance of Walden facilities. The Club House was painted inside and out with power washing and replacement of gutters and fascia boards for \$6,932.The pool received new coping tiles, plaster liner, and additional steps for a total of \$45,592.The Walden Glen entrance received an update and the addition of new landscape and flowers for \$6,000. Walden finished 2015 with \$20,517 in our checking account and Escrow/Reserve of \$25,086.

The Homeowners Association Board approved the 2016 Operating Budget at \$60,867.31. This will cover fixed costs associated with operating the neighborhood and Variable expenses for minor repair and maintenance. We will continue to rebuild the Escrow/reserve to allow for future projects. Homeowner Dues will remain at \$350 per year payable on 1 June 2016.

In 2015 there were 16 Home closings or Refinancing's and each one required a statement from the HOA Treasurer prior to closing that dues were paid in full. Please provide your closing agent or real estate agent the Walden Treasurer's Name and Email. <u>Jamese4830@aol.com</u>
